Priority Course Registration & Children & Spouses of Deceased or Disabled Veterans	See statute for additional information
Priority course registration for veterans, spouses and dependent children FS 1004.075	Each Florida College System institute and state university which offers priority course registration for a segment of the student population shall provide priority course registration for veterans, <u>& spouses and dependent</u> children who are receiving transferred GI Bill® education <u>benefits.</u> Priority course registration expires when GI Bill® education benefits exhaust Priority course registration is now posted on the GI Bill® Comparison Tool
Scholarships for Children and Spouses of Deceased or Disabled Veterans <u>FS 295.01</u>	Tuition and Fees at a <u>public Florida institution OR</u> the equivalent scholarship at an <u>eligible private institution</u> in Florida. Residency requirements enforced 2015=\$3.1 mil → 2022=\$13.48 mil <u>www.floridastudentfinancialaid.org</u>

Tuition and / or Related Fees	See statutes for additional information
Tuition Deferment FS 1009.27	Any veteran or eligible student receiving VA Ed benefits is entitled to 1 deferment each academic year and an add'l deferment when delay in the receipt of benefits
Withdrawal due to military service FS 1004.07	Enrolled student shall not incur academic or financial penalties by virtue of performing military service

Active Duty Servicemembers using DoD's Military Tuition Assistance (TA)	In 2014 TA commenced paying only tuition for active duty servicemembers enrolled in postsecondary institutions. Florida College System institutions may now waive fees for active duty servicemembers when they are receiving
HB 75, to create FS 1009.26(15)	 TA. Fees which may be waived by the institution include: Student Activity and Service Fee Financial Aid Fee Technology Fee Capital Improvement Fee, and Any other Fees authorized in FS 1009.23
Fee Exemptions at a school district that provides workforce education programs, Florida Community College System institutions or state university <u>FS 1009.25</u>	Dual enrollment students; Certain Department of Children and Family Services students; Student who lacks fixed, regular and adequate nighttime
	Student who lacks fixed, regular and adequate nighttime

Waived tuition and / or related fees <i>FS 1009.26</i>	See statute for additional information
Persons 60 years of age or older, on a space-available basis FS 1009.26(4)	A state university may waive any or all application, tuition and related fees for persons 60 years of age or older who are residents of Florida and who audit classes
State of Florida Employee Tuition & Fee Waiver Program FS 1009.265	A state university and Florida College System institution may waive tuition and fees for state of Florida employees for up to 6 credit hours per term on a space availability basis. Fee-paying students have priority in enrollment.

Florida Postsecondary Institutions to Waive Transcript Fee for certain individuals <i>Effective 6/23/2020</i>	Florida's Public, Postsecondary Institutions are to <u>waive the</u> <u>transcript fee</u> of Active Duty Members or Honorably Discharged Veterans, including his/her spouse and dependents
<u>HB 171</u> , to amend <u>FS 1009.26(17)(a)</u>	
Educator Certification Pathways for Veterans Awaiting Governor's Signature	Provides for an alternative pathway for veterans seeking subject area teaching certification in Florida with issuance of a temporary educator certificate

Uniform Awarding of Postsecondary Credit Earned While in the Military	Florida's Articulation Coordinating Committee (ACC) is to create a process for the uniform awarding of Florida postsecondary credit or career education clock hours to certain service members and veterans of the United States Armed Forces. Timeline of Required Actions:
Effective Date: To Be Determined	By July 15, 2020 – A workgroup is established; By December 1, 2020 – The workgroup shall provide the

Florida residency granted for In-State Tuition and / or Fees	See statute for additional information
Active Duty members and in-state tuition FS 1009.21(10)(a)	The following persons shall be classified as residents for tuition purposes: Active duty members of the Armed Services of the U.S. residing or stationed in Florida, their spouses and dependent children and active drilling members of the Florida National Guard; Active duty members of the Armed Services and their spouses and dependents attending a College System institution or state university in Florida within 50 miles of the military establishment where they are stationed, also outside of Florida, if it is within a county contiguous to Florida
Serving in Armed Forces outside the state FS 1009.21(7)	A person, or dependent child, shall not lose resident status for tuition purposes solely by reason of serving in Armed Forces outside this state.



Residency requirement for state veteran nursing homes FS 296.36	Veteran must be a Florida resident at the time of application, but there's no longer a one-year residency requirement for acceptance into one of the six state veteran nursing homes in Florida
Florida is for Veterans, Inc. (Effective 4/24/2015, Brands itself as 'Veterans Florida') FS 295.21, 295.22, 295.23 In 2020 appropriated a \$344,106 grant	Created a nonprofit corporation within FDVA to promote Florida as a veteran-friendly state. The corporation will encourage and assist retired and recently separated military personnel to keep or make Florida their permanent residence and help equip veterans for employment opportunities and promote veteran hiring
